



**DIRECTIVE FOR THE  
FEBRUARY 27, 2025 GENERAL ELECTION  
FOR ALL ELECTORAL DISTRICTS**

**MODIFICATIONS TO THE COUNTING TIMES FOR SPECIAL BALLOT**

**WHEREAS** a significant number of electors have voted from Day 28 to Day 1 by Special Ballot.

**AND WHEREAS** due to the significant number of votes cast by Special Ballot, the timely counting of Special Ballots and the reporting of results could be significantly delayed.

**AND WHEREAS** section 3.7 of the *Election Act*, R.S.O. 1990 c E.6 (the "**Act**") authorizes the Chief Electoral Officer to give directions in cases of mistake, miscalculation, emergency, unusual, or unforeseen circumstances.

**AND WHEREAS** in order for the timely counting of Special Ballots and reporting of results, I will invoke section 3.7 of the Act to permit election staff to commence counting Special Ballots cast in-person at the returning office or during home visits in accordance with the times set out for each electoral district in Schedule "A" hereto.

**AND WHEREAS** in order for the timely counting of Special Ballots and reporting of results, I will invoke section 3.7 of the Act to permit election staff to commence counting Special Ballots cast pursuant to the vote by mail program in accordance with the times set out for each electoral district in Schedule "B" hereto.

**AND WHEREAS** in order for the timely counting of Special Ballots and reporting of results, I will invoke section 3.7 of the Act to permit election staff to commence counting Special Ballots returned to Elections Ontario Headquarters in accordance with the time set out in Schedule "C" hereto.

**NOW THEREFORE, I HEREBY DIRECT**, pursuant to section 3.7 of the Act, that the Returning Officer commence counting Special Ballots cast in-person at the returning office or during home visits in accordance with the times set out for each electoral district in Schedule "A" hereto.

**I HEREBY DIRECT**, pursuant to section 3.7 of the Act, that the Returning Officer commence counting Special Ballots cast pursuant to the vote by mail program in accordance with the times set out in Schedule "B" hereto.

**I HEREBY DIRECT**, pursuant to section 3.7 of the Act, that election staff at Elections Ontario Headquarters commence counting Special Ballots returned to Elections Ontario Headquarters in accordance with the time set out in Schedule "C" hereto.
